TPA will furnish to Casper, Wyoming, for personnel ordered to that sta per this Par, the nec fld ranges, cooking and serving utensils, and arrange for the return of same to TO this sta, provide the nec ice and cleaning supplies; provide three (3) meals (tr tn rat) for each person, increased by thirty-three and one-third per cent (33 1/3%) of the total number of meals for the total number of days or fraction thereof required to make the journey. (Par 3, WD Cir 341, 29 December 1943) TM will make the proper installation of the nec fld ranges in kitchen car or cars and provide the nec fuel. The Tn Comdr is responsible for the immediate return of fld ranges, cooking and serving utensils to proper sta.

It being impracticable for the Govt to furnish rat in kind, ED will pay at destination a mon alms in lieu thereof a/r \$3.00 per day for two-third (2/3) day to SGT JAMES W ANDRUS (CR #9353) performing TPA to Casper, Wyoming, UP AR 35-4520, Ch #5, 21 January 1944.

Payment of three (3) cents per mile is atzd at destination for any portion of the journey for which Govt T/R is not furn, under auth of AR 35-4540, Ch-2.
